**A RESOLUTION FIXING COUNTY MILL LEVIES TO BE ASSESSED UPON ALL  
PROPERTY WITHIN HINSDALE COUNTY, STATE OF COLORADO, FOR THE  
FISCAL YEAR 2020, AND CERTIFYING SUCH LEVIES.**

**WHEREAS**, The Board of County Commissioners shall adopt the annual budget by December 31, 2020, in accordance with the Local Government Budget Law; and

**WHEREAS**, the Board of County Commissioners has made provisions therein for revenues including property taxes; and

**WHEREAS**, pursuant to C.R.S. 39-5-128(1) that all mill levies required to be fixed and certified to the Board of County Commissioners by December 15, 2020 have occurred.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HINSDALE COUNTY, COLORADO** that the following tax levies be fixed and sums be hereby assessed upon all property within the limits of Hinsdale County based on a total assessed valuation of \$58,412,290 for the year 2020 as submitted by the Hinsdale County Assessor on November 25, 2020.
