**A RESOLUTION RESCINDING STAGE 2 FIRE RESTRICTIONS IN THE UPPER PIEDRA  
REGION OF UNINCORPORATED SOUTHERN HINSDALE COUNTY**

WHEREAS, pursuant to 30-15-401(1)(n.5), C.R.S., the Board of County Commissioners of Hinsdale County, Colorado ("Board") adopted Ordinance No. 1, Series 2012, An Ordinance Establishing a Permanent Process to Periodically Ban Open Fires Within the Unincorporated Areas of Hinsdale County, Colorado, ("Fire Ban Ordinance"); and

WHEREAS, pursuant to the Fire Ban Ordinance, the Board has the authority at any meeting, by resolution, to ban open fires to a degree and in a manner that the Board deems necessary to reduce the danger of forest fires and/or grass fires within those portions of the unincorporated areas of Hinsdale County where the danger of forest fires and/or grass fires is found to be high based on competent evidence; and

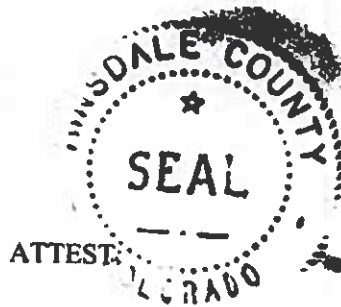
WHEREAS, the Board adopted Resolution 14, Series 2022, implementing Stage Two (2) fire restrictions in the Upper Piedra region of southern unincorporated Hinsdale County on June 15, 2022; and

WHEREAS, San Juan National Forest terminated Stage Two fire restrictions and returned to Stage One restrictions on June 24, 2022, and based on recent rainfall and other competent evidence, the Board has determined that Stage Two fire restrictions will be rescinded and Stage One restrictions will be implemented at this time in the Upper Piedra region of southern unincorporated Hinsdale County.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Hinsdale, State of Colorado that as of June 24, 2022, at 9 a.m., the previously instituted Stage Two Fire Restrictions in the Upper Piedra region of southern unincorporated Hinsdale County are rescinded and Stage One restrictions will be implemented until further notice.

This Resolution has effect upon its passage by the Board of County Commissioners of Hinsdale County, Colorado, without further action necessary.
