

**A JOINT RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
HINSDALE COUNTY, COLORADO AND THE HINSDALE COUNTY SCHOOL
DISTRICT BOARD OF EDUCATION ALLOCATING U.S. FOREST SERVICE
SECURE RURAL SCHOOLS TITLE I MONIES RECEIVED PURSUANT TO § 30-29-
101, C.R.S. FOR FISCAL YEARS 2022, 2023, AND 2024**

RESOLUTION NO. 20, SERIES 2022

WHEREAS, Hinsdale County received \$375,053.50 in 2022 from the Treasurer of the State of Colorado pursuant to § 30-29-101, C.R.S., which are Secure Rural Schools (SRS) Title I funds originating from the U.S. Forest Service; and

WHEREAS, three persons representing the Board of County Commissioners of Hinsdale County, Colorado and three persons representing the Hinsdale County School District must allocate the SRS funds pursuant to § 30-29-101, C.R.S.; and

WHEREAS, the Boards referenced above have met, and this Resolution addresses the split of the 2022 SRS funds between the Hinsdale County Road and Bridge Fund and the Hinsdale County School District, as required by Colorado law.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF HINSDALE COUNTY, COLORADO AND THE HINSDALE
COUNTY SCHOOL DISTRICT BOARD OF EDUCATION, AS FOLLOWS:**

1. The Title I SRS monies received by Hinsdale County in the amount of \$375,053.50 for fiscal year 2022 shall be allocated as follows:
 - a. Title I Hinsdale County Road and Bridge Fund: \$187,526.75
 - b. Title I Hinsdale County School District RE-1: \$175,431.28
 - c. Title I Archuleta School District No. 50 Joint: \$12,095.47

2. The Title I SRS monies that Hinsdale County is due to receive in 2023 and 2024 shall be split 50-50 between the Hinsdale County Road and Bridge Fund and the Hinsdale County School District. For purposes of this Resolution and the disbursement of the Title I SRS monies, the Hinsdale County School District includes Hinsdale County School District RE-1 and Archuleta School District No. 50 Joint.
