**RESOLUTION NO. 23

A RESOLUTION AUTHORIZING THE COUNTY ASSESSOR TO SETTLE, WITHOUT FURTHER APPROVAL BY THE BOARD OF COUNTY COMMISSIONERS, ABATEMENT PETITIONS IN WHICH THE ABATEMENT OR REFUND IS IN THE AMOUNT OF TEN THOUSAND DOLLARS (\$10,000) OR LESS PER TRACT, PARCEL, OR LOT OF LAND OR PER SCHEDULE OF PERSONAL PROPERTY

WHEREAS, pursuant to C.R.S. § 39-1-113(1.5), the Board of County Commissioners of Hinsdale County, Colorado (“BoCC”) may authorize the Hinsdale County Assessor to review petitions for abatement and settle by mutual agreement with the property owner any such petition for abatement or refund in an amount of ten thousand dollars (\$10,000) or less per tract, parcel, or lot of land or per schedule of personal property; and

WHEREAS, the BOCC previously provided the Hinsdale County Assessor with the authority to settle petitions for abatement or refund in an amount of one thousand dollars (\$1,000) or less per tract, parcel, or lot of land or per schedule of personal property by and through BoCC Resolution No. 9, Series 1994 which was adopted on April 6, 1994 (“1994 BoCC Resolution”); and


WHEREAS, the BoCC hereby desires to replace the 1994 BoCC Resolution with this 2022 Resolution that will serve to increase the authority of the Hinsdale County Assessor to settle abatement petitions from one thousand dollars (\$1,000) or less to ten thousand dollars (\$10,000) or less.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HINSDALE COUNTY, COLORADO THAT:

1. The 1994 BoCC Resolution is hereby repealed and replaced by this Resolution.
2. Pursuant to C.R.S. § 39-1-113(1.5), the Hinsdale County Assessor may review petitions for abatement and settle by mutual agreement with the property owner any such petition for abatement or refund in an amount of ten thousand dollars (\$10,000) or less per tract, parcel, or lot of land or per schedule of personal property.
