**A RESOLUTION CANCELING UNCOLLECTABLE POSSESSORY INTEREST
TAXES THAT HAVE BEEN DELINQUENT FOR MORE THAN ONE YEAR**

WHEREAS, pursuant to Colorado Revised Statutes section 39-10-114(2)(a), the Board of County Commissioners is empowered to cancel any taxes levied on personal property, including but not limited to mobile homes, which are determined to be uncollectible after a period of one year after the date of their becoming delinquent; and

WHEREAS, the taxes levied on possessory interests listed on Exhibit A have been delinquent in excess of one year; and

WHEREAS, these same taxes are uncollectible; and

WHEREAS, the County Treasurer has requested that these taxes be written off;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, Hinsdale County, Colorado, that the possessory interest taxes set forth on attached Exhibit A and incorporated herein are hereby declared uncollectible and the Hinsdale County Treasurer is authorized to cancel these taxes as she deems appropriate.
