A JOINT RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF HINSDALE COUNTY, COLORADO AND THE HINSDALE COUNTY SCHOOL DISTRICT BOARD OF EDUCATION ALLOCATING U.S. FOREST SERVICE SECURE RURAL SCHOOLS TITLE I MONIES RECEIVED PURSUANT TO § 30-29-101, C.R.S. FOR FISCAL YEARS 2016 AND 2017

HINSDALE COUNTY BOARD OF COUNTY COMMISSIONERS RESOLUTION NO. 8, SERIES 2018

WHEREAS, Hinsdale County received \$62,858.66 in 2017 for fiscal year 2016 from the Treasurer of the State of Colorado pursuant to § 30-29-101, C.R.S., which are Secure Rural Schools (SRS) funds originating from the U.S. Forest Service; and

WHEREAS, Hinsdale County received \$312,033.77 in Title I monies in 2018 for fiscal year 2017 from the Treasurer of the State of Colorado pursuant to § 30-29-101, C.R.S., which are also SRS funds originating from the U.S. Forest Service; and

WHEREAS, three persons representing the Board of County Commissioners of Hinsdale County, Colorado and three persons representing the Hinsdale County School District must allocate the SRS funds mentioned above pursuant to § 30-29-101, C.R.S.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF HINSDALE COUNTY, COLORADO AND THE HINSDALE COUNTY SCHOOL DISTRICT BOARD OF EDUCATION AS FOLLOWS:

- 1. That the SRS monies received by Hinsdale County in 2017 for fiscal year 2016 in the amount of \$62,858.66 shall be allocated to the Hinsdale County School District.
- 2. That the Title I SRS monies received by Hinsdale County in 2018 for fiscal year 2017 in the amount of \$312,033.77 shall be allocated as follows:
 - (a) Hinsdale County Road & Bridge Department: \$78,008.44 (25% of total) + \$109,437.78 for a total of \$187,446.22; and
 - (b) Hinsdale County School District: \$78,008.44 (25% of total) + \$46,579.12 for a total of \$124,587.56.
