Concerning: The Off-Highway Vehicle Pilot Project on Hwy 149

Dear Mr. Goolsby:

This letter is in protest to the pilot program initiated by CDOT Region 3 for Off-Highway Vehicle (OHV) to travel on Hwy 149 South of Lake City.

Our full-time residence since 2006 is on Hummingbird Lane that exits off of Hwy 149 approximately 100 yards from mile marker 70, near the center of the pilot project under study. Due to my longevity at this location I feel uniquely qualified to provide a report on the conditions of this study area. My concerns are listed below:

- 1) It should also be noted that the map attached to your July 19, 2018 Memorandum to the Transportation Commission illustrates the pilot area as a near straight line. This section of the highway is certainly not straight, including dangerous curves, blind entrance driveways, and narrow shoulder drop-offs. I have walked along the shoulder of this section of Hwy 149 in the past; however, now it is no longer safe. There is simply not enough room to walk by the side of the pavement, away from the increased traffic.
- 2) There is one, short straight section near MM 70 that I must slow down to turn left off the highway onto Hummingbird Lane, and more than once, been passed on the left by speeding vehicles.
- 3) Generally, the OHVs are very noisy. With mountains on either side, the sound carries throughout the valley. CDOT should accurately measure the noise level in this area.
- 4) CDOT carries a standard for vehicles that are allowed on highways, primarily for safety. These OHVs are not qualified and should not be allowed specifically due to safety concerns.
- 5) The pilot has made the alpine loop into a speedway. The OHVs are capable of much greater speed and your pilot program completing this loop is facilitating or enabling this insatiable desire to hurry, resulting in unsafe conditions.
- 6) CDOT by state statue, specifically Section 33-14.5-108(a) C.R.S. may designate a public road open to OHVs, however there is no structure defined to implement this decision, such as mandatory signage and public notification including local sheriff, state police, and affected residence driveways and side roads.

Please picture in your mind logging trucks, bicycles and OHVs on the same narrow, mountainous highway, with no shoulders, blind turns and residential driveways. How can this be safe for public transportation? The primary CDOT mission should be public safety.

In summary, by allowing OHVs on this already dangerous section of mountainous road, CDOT is not providing safe travel on this section of state highway 149, a primary and fundamental mission of your organization. The OHV pilot program should be immediately abandoned.

To Whom It May Concern,

We are 44-year residents and business owners in Lake City and Hinsdale County. We have seen a lot of changes in that time, some good and some not so good. But the shortsighted, arrogant decision to override Colorado State law and allow Off Highway Vehicles (OHVs) on the State Highway is by far the worst. A Court of Law decided in 2018 that it was illegal for OHVs to operate on State Highways. Period. Yet the powers-that-be found a way to ignore that law and implement the OHV Pilot Program.

The CO149 OHV Pilot Program has negatively impacted the community of Lake City and Hinsdale County in several ways:

- A significant and harmful increase in noise pollution
- Increases in dust in the air and a corresponding increase in respiratory distress especially within older citizens
- Damage to the dirt roads throughout the county
- A rise in dangerous conflicts with legal vehicles on the highway
- Increased costs in terms of maintenance and no commensurate fees to cover those costs as OHVs pay no fees

Now, those same powers-that-be want to continue to ignore State Law and extend the CO149 Pilot Program not just geographically but also to a full twelve months of the year. The main proponents of the extension of the CO149 OHV Pilot Program are a small number of Lake City residents who simply want to be able to drive their OHVs wherever and whenever they want. The residents of Hinsdale County have not been given a voice nor have they been allowed to participate in the decision about the CO149 OHV Pilot Program because voting on the issue was limited only to Lake City residents rather than the entire county. This small cadre of people have been able to maneuver around the laws and shove their selfish desires down the throats of the residents of Hinsdale County. That isn't fair and it isn't right!

Because OHV riders do not pay fees, as do owners of legal vehicles, the burden of paying for the damages they cause is shouldered by the taxpayers of Hinsdale County the majority of whom don't own an OHV. Yet again this isn't fair and it isn't right!

We are not opposed to change and embrace the notion that change is needed in order for there to be progress. OHV riders adhere to it without complaint. There are staging areas where OHV riders can unload and drive their vehicles on appropriate roads and trails. This is a system that works and is well understood by OHV riders. It also is in line with other states that similarly legislate OHVs.

We are asking you to discontinue the CO149 OHV Pilot Program. We want a community that is manageable for all and where residents, visitors and OHV riders can co-exist harmoniously. We do NOT want to be the only community is the state that has willfully ignored a law just so a few people can do whatever they want at the expense of the rest.

I co-own and operate The Sportsman Outdoor & Fly Shop located in Hinsdale County at the edge of Lake City's southern boundary on Colorado Highway 149. The business has been in existence since 1955; and I've owned it for 23 years. It is nearly 100-percent reliant on tourism. I also own a home in the Town, and I have invested my time and money to its continued success in all manner...Town, County, Schools, and so on.

In the dark days, before OHVs were allowed, I felt our business was always in jeopardy of financial ruin. We have always worked long, hard hours to keep it going; but before OHVs, we simply never felt we could make it through the year. There were many sleepless nights.

Without question, allowing OHV use of Highway 149 to enable OHVs to complete the Alpine Loop has been the single, most beneficial improvement to business that we have ever seen in 23 years. OHV tourism means increased gross sales across the board for my outdoor store. Many OHVers want to expand their recreational activities into hiking, fishing, and fly fishing and come to our store to learn about the area and purchase items that help them in these endeavors.

Absolutely no other market segment, from second homeowners, locals, hikers, or even fishers, have ever improved our sales outlook. This group has both the income and propensity to buy local. This is not common among any other market segment.

And it's not just our Lake City businesses and community that will feel the impact of a negative decision for the OHV program. We bring more products into our store for the OHV community. Should the pilot program be canceled, I will be

forced, like other local businesses, to reduce greatly my inventory. In fact, I will have to eliminate preseason orders that I've already submitted. Without the OHV market segment, there simply is no one around to buy product.

Je certainly respect the need for regulation and enforcement. If there are issues, let's discuss them and enable enforcement of existing and common-sense regulations. We want to encourage smart, respective growth. We do not encourage the vilification of individual visitor groups such as we've seen with OHV enthusiasts.

In the past three years, we have faced drought, flood, and now pandemic. Through it all, the OHV community has supported us and without them, I doubt that we could have come through it. Now the pandemic continues, as has yet another drought this year. Frankly, I don't know what will happen next year, but water conditions, snow-pack, and continued pandemic are huge factors that could put many of us over that edge.

I'm busy working to keep my business afloat and viable and keep my family going. I encourage safe and regulated OHV use, including the continuation of the program to enable OHVs to use Highway 149. I encourage you to enable this use. Maybe then we business owners in Lake City can pay our mortgages; put food on the table; raise our children; and sleep again.

Please accept this letter of my support in favor of continuing the pilot program allowing off road vehicle (OHV) access between Hinsdale County Road 20, extending to the Toy Carwash, on the north and County Road 30, extending south via Colorado Highway 149 to Woodlake Park for the purpose of completing the Alpine Loop and providing access to the town.

I am one of the owners and operators of The Sportsman Outdoor and Fly Shop located in Hinsdale County at the edge of Lake City's southern boundary on Colorado Highway 149. This iconic business is one of the oldest (established in 1955) and the largest retail, tour, and guide service provider in Hinsdale County.

During the last 23 years, we have had the privilege of living in and raising our family in this small community in which we are heavily invested with a business and home here. However, our business is almost 100-percent reliant on tourism, and it is extremely difficult to make it here with such a short tourism season and being in such an out-of-the way, unknown location. We, like all of the other businesses in Lake City, have about an 8- to 10-week time period in which we must bring in enough income "to make it" for the entire year. Believe me, there have been years where "making it" caused difficulties for many families here, including my own.

Since the increase in OHV activity, and especially with the advent of the pilot program that enables riders to connect the Alpine Loop using Highway 149, we have seen a substantial increase of positive cash-flow to our business and the community as a whole. Without this improved revenue, we do not believe we could afford to send our child to college without having to take on even more of a debt load than what we already have. Additionally, we have been able to bring

on additional staff to accommodate the increase in business, again increasing the overall economic status of our town and county.

LAV enthusiast who have ridden through Lake City from the other side of the Alpine Loop have often returned to stay with our lodging facilities, again supporting restaurants and shops, and essentially the whole community. They are appreciative of our small town and want to support it and the people who call it home.

With recent flood threats, droughts, and pandemics, we do not have the luxury of vilifying and alienating any group of visitors. That is not what an inclusive, welcoming, considerate, and sharing community would do. Issues can be resolved with considerate communication and enforcement of rational regulations.

I also feel that the year-round viability of this small community should not be sacrificed for the benefit of a small group who feel that "any" tourist growth is offensive and unacceptable. This same group fighting against OHVs today have often fought against other groups of tourists, and this is just the latest group to receive their rage.

I and my family live here year-round and try to make a living here. We appreciate anyone's contribution to community. But it is not a Shangri-la for the well-off and well-placed. Without the contribution of OHVers, which is enabled by the Highway 149 program, the community will again be facing sales tax shortfalls, closures, and bankruptcies, which I and other community businesses have often seen over the years, and continually battle against ourselves.



The proponents of continuing and extending travel on Hwy 149 say, "Well, it was the same thing when jeeps started traveling on the highway and the Alpine Loop." No it wasn't. Viewing the Alpine Loop in a jeep going 5-10 mph and stopping to let others by was the norm.

Also as for finical benefit, I have seen more business close since the inception of the Pilot Program, and I have a 44 year history to compare it to.
