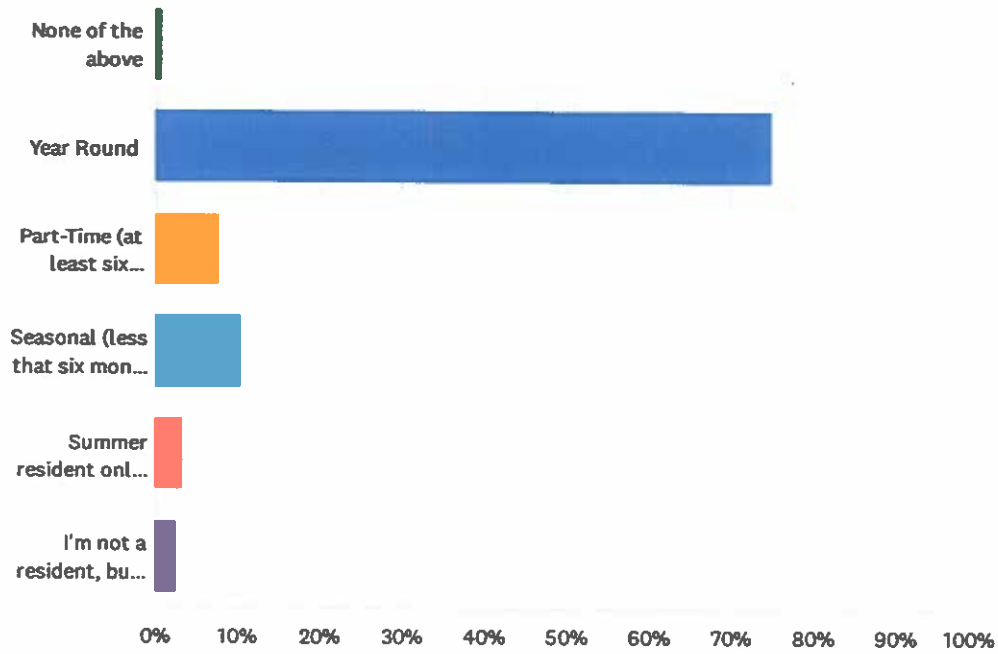

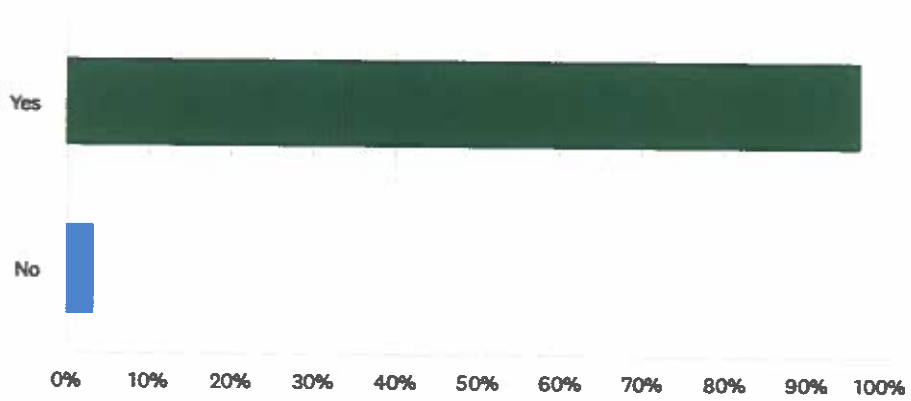

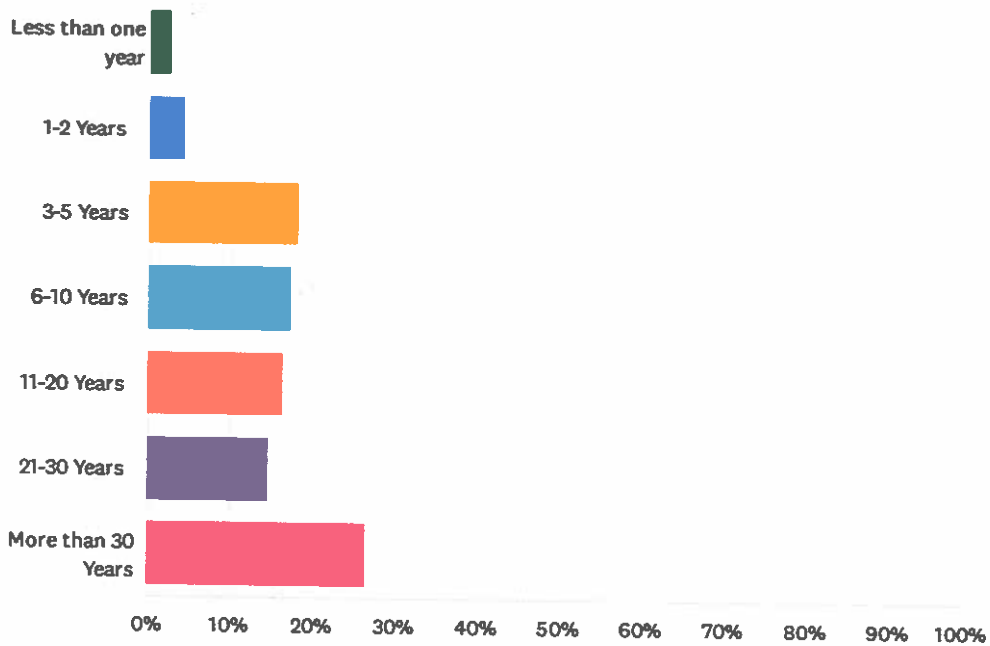

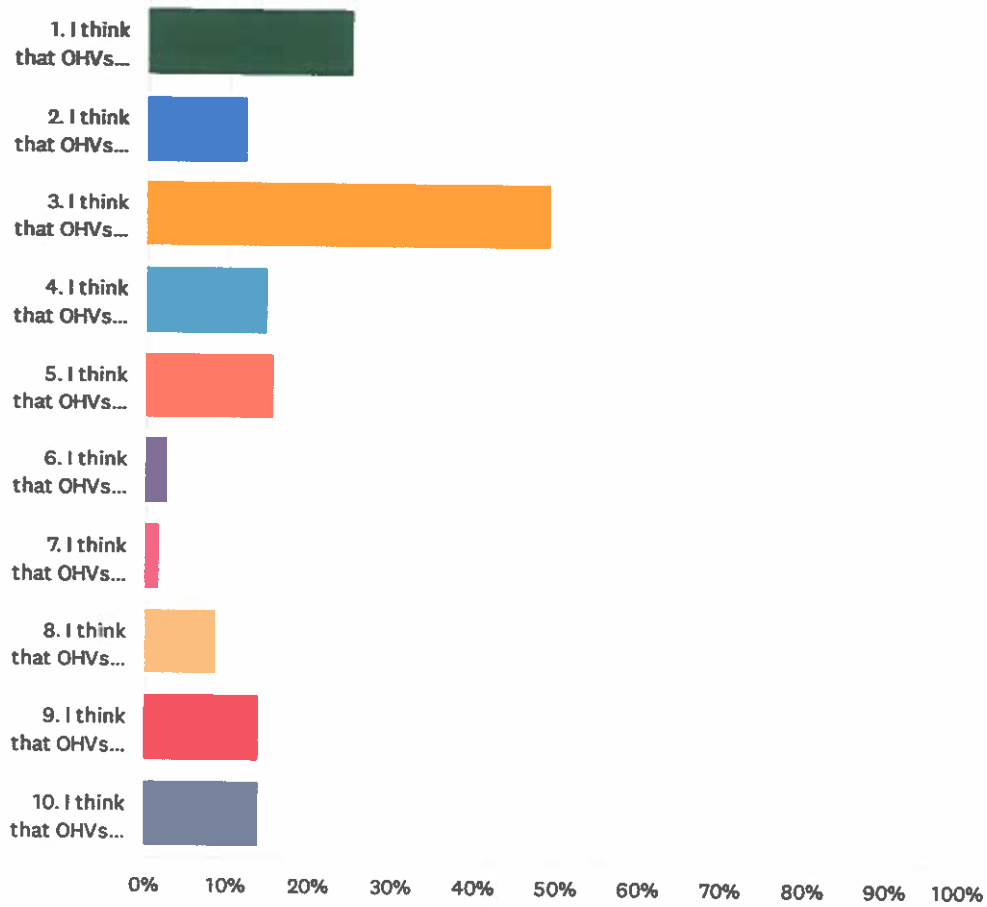

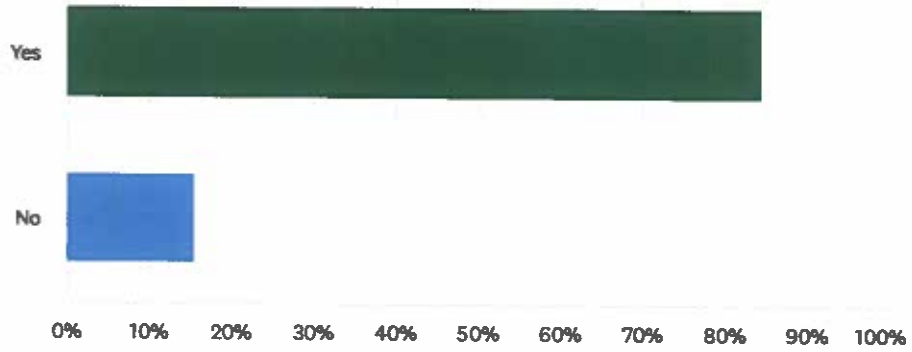

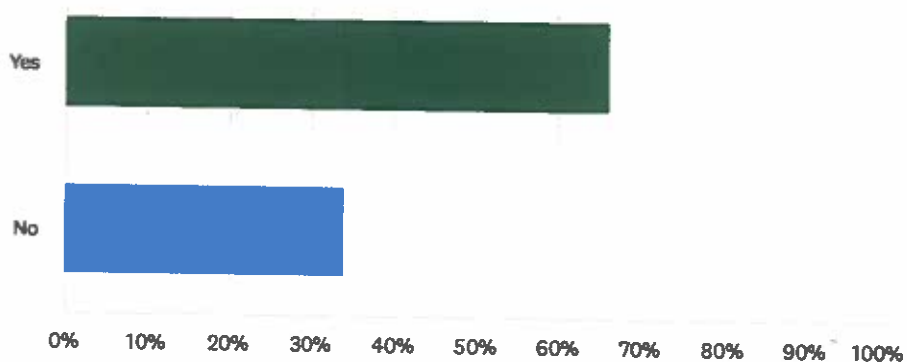

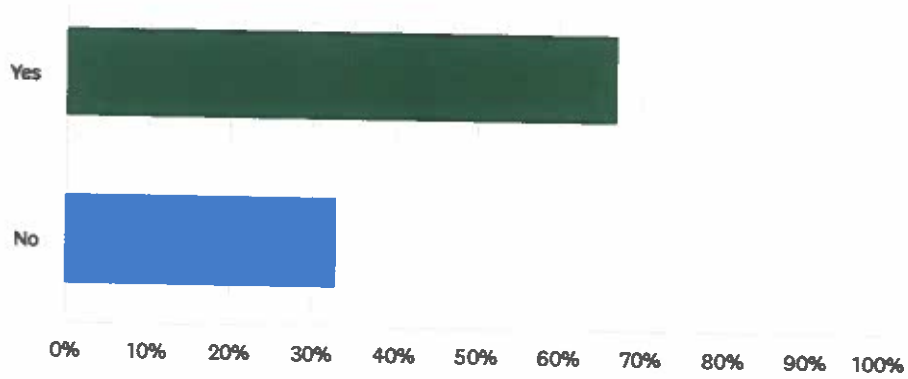

Q15 If possible, do you think Hinsdale County should implement an additional permit to operate OHVs on our county roads?

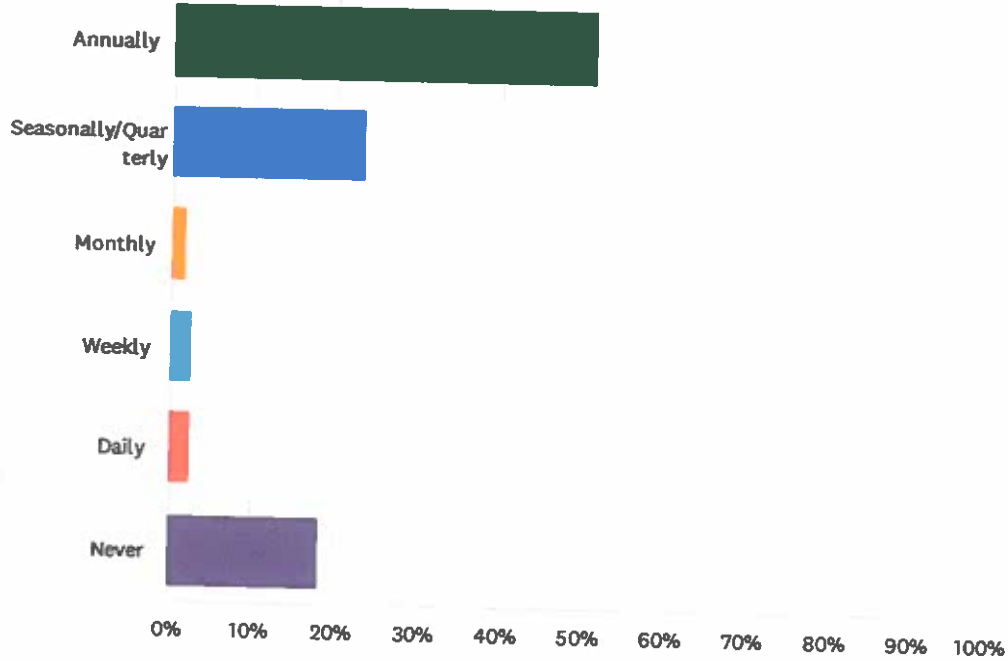

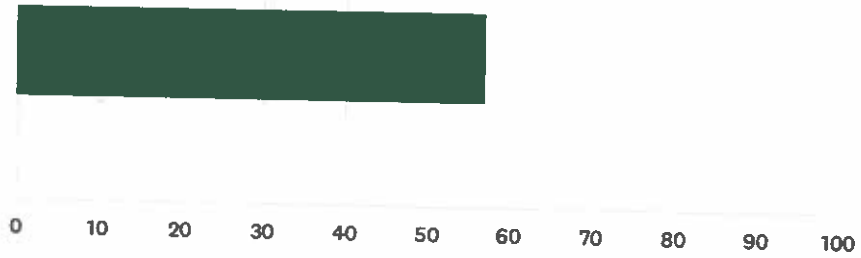

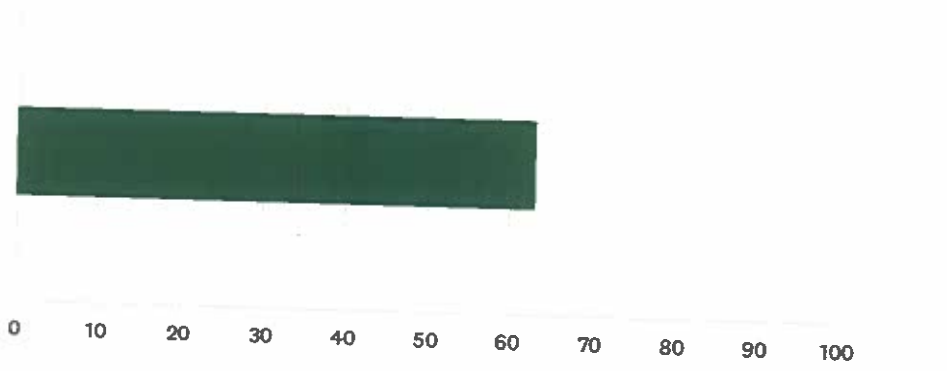

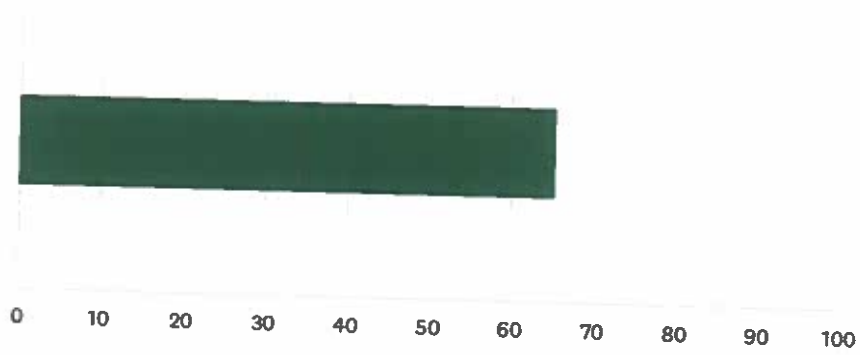

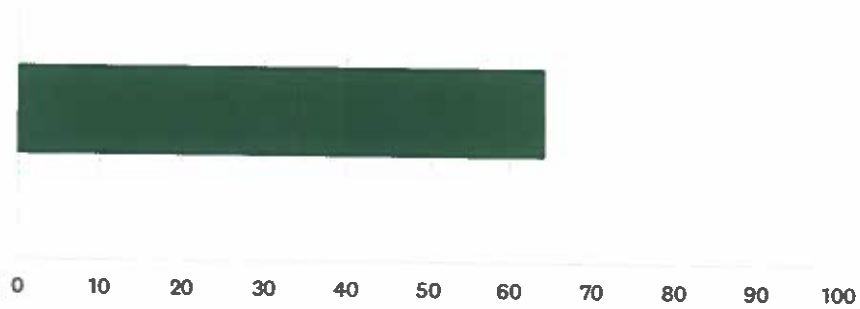

Q22 Tax Revenue

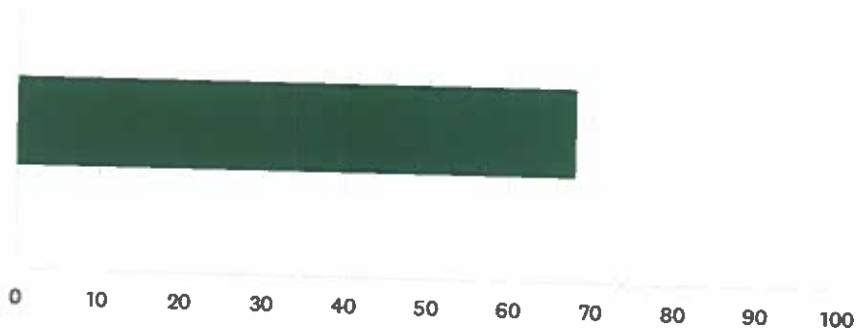

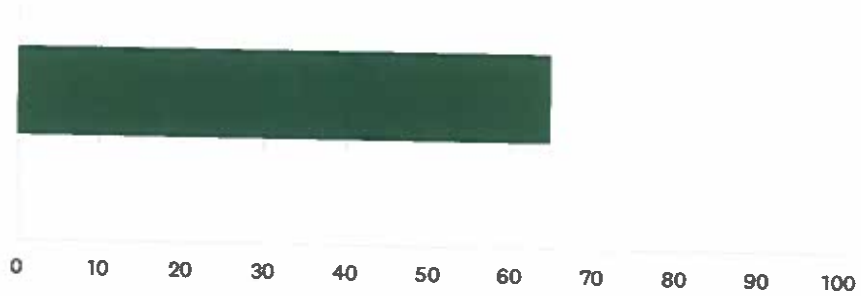

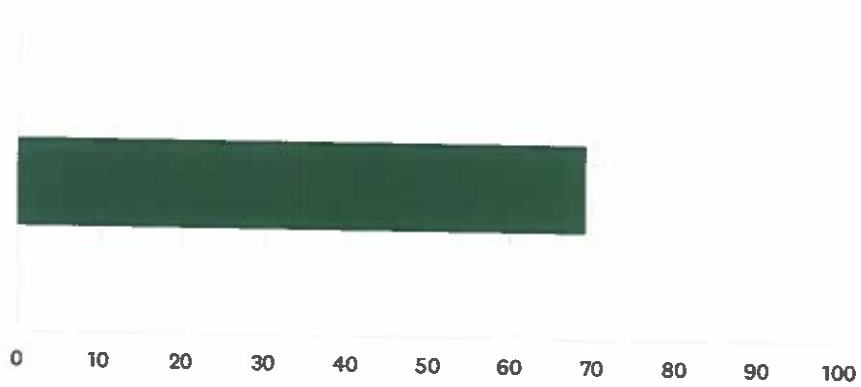

Q25 Deterioration of the Roads

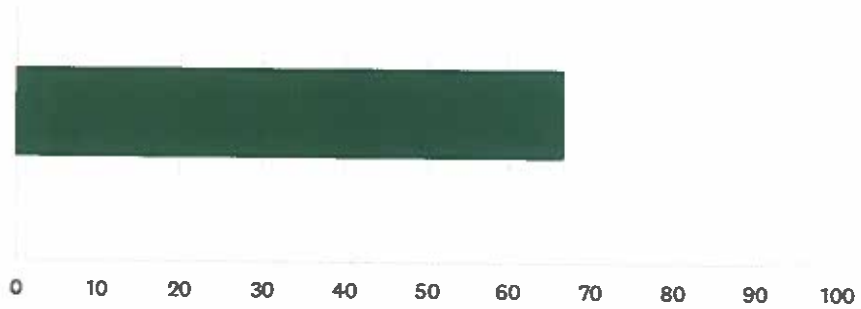

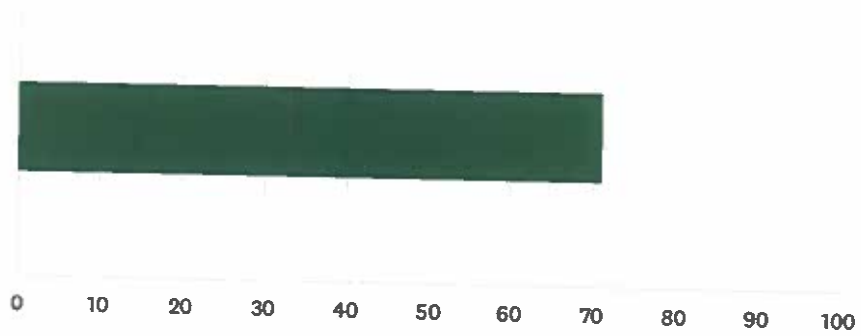

Q27 Safety Concerns

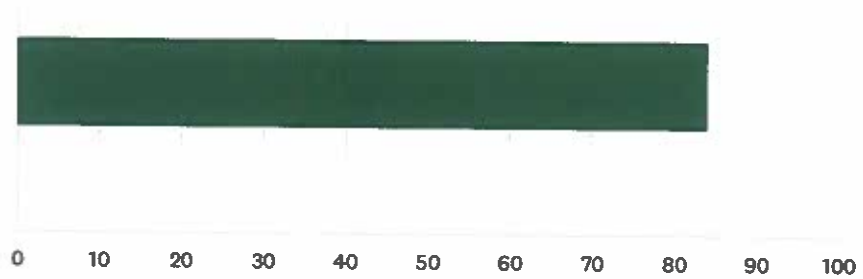

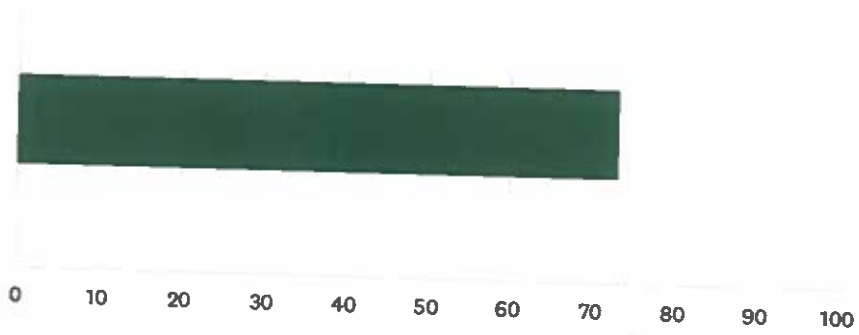

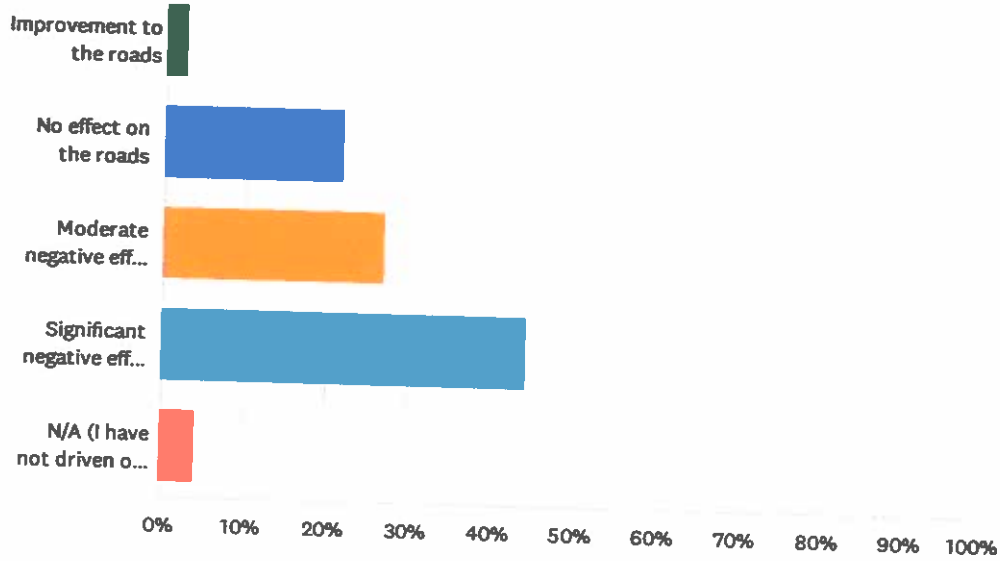

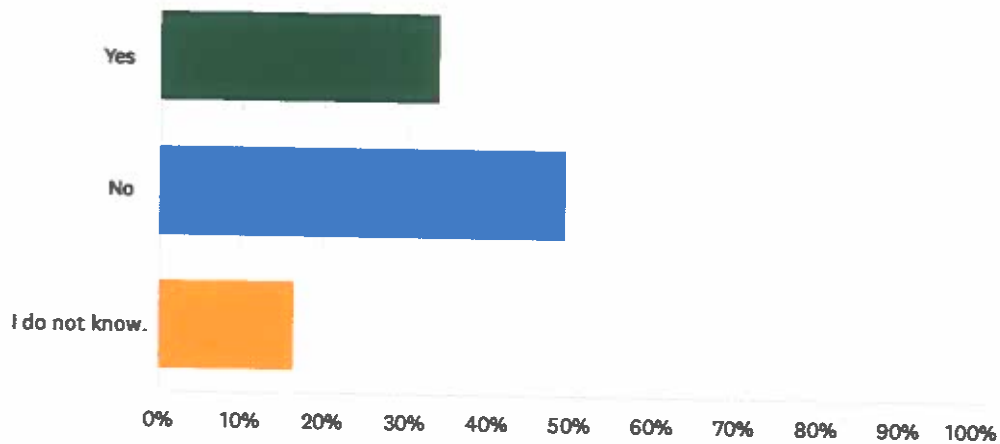

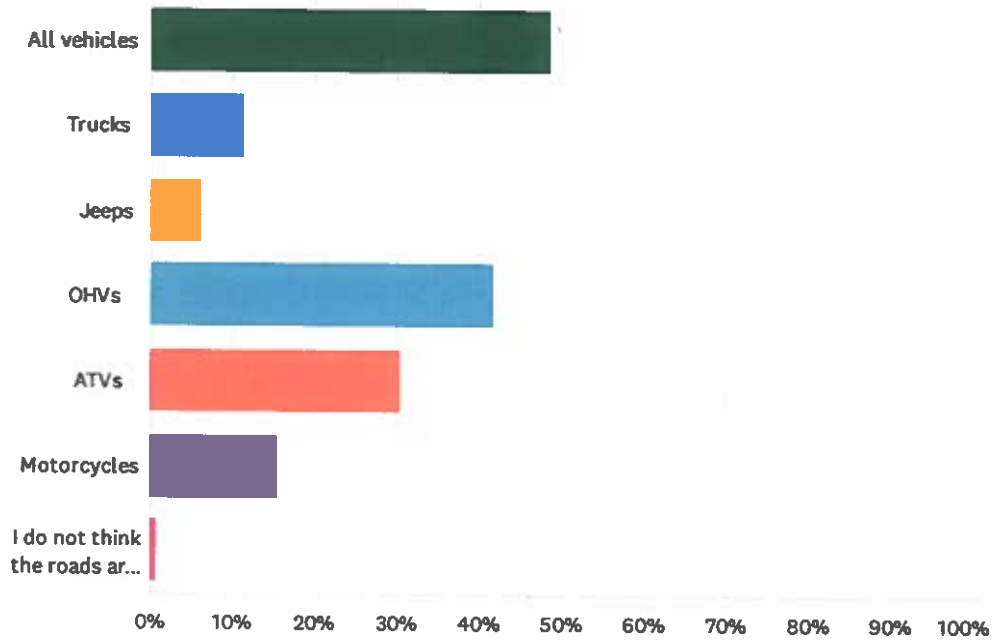

Q34 Which vehicles do you believe are affecting the unpaved county roads the most?

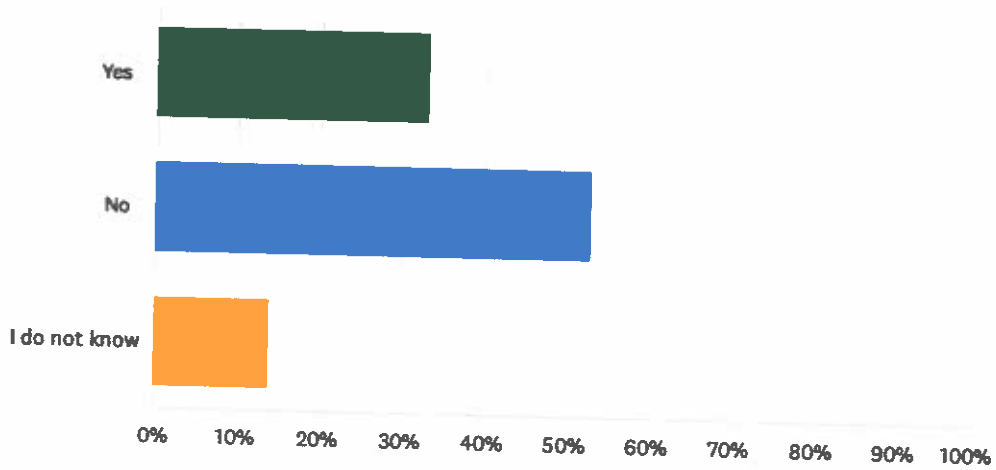

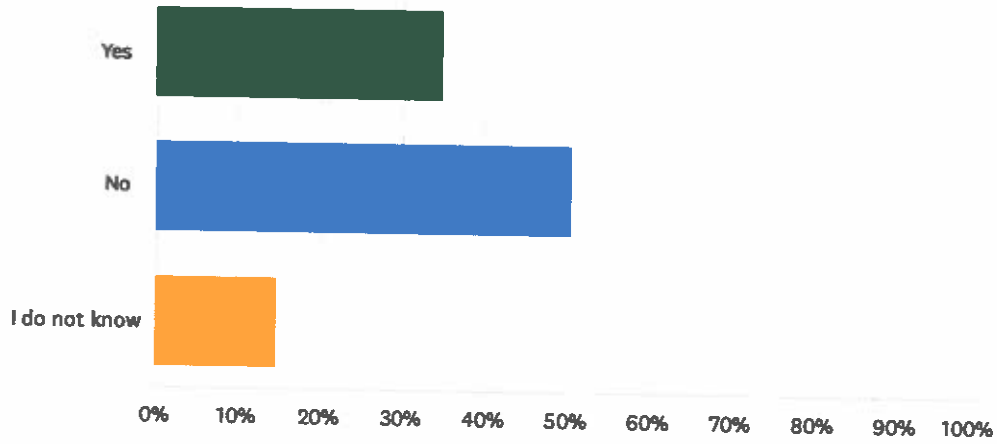

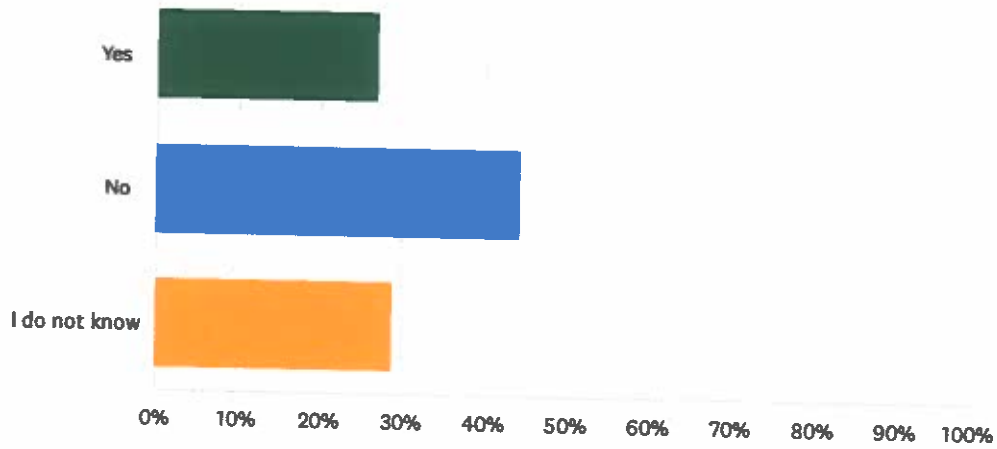

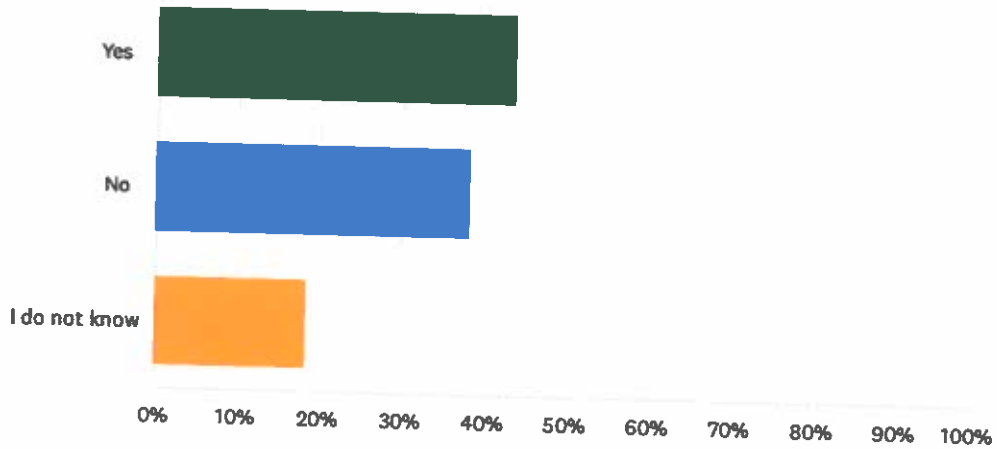

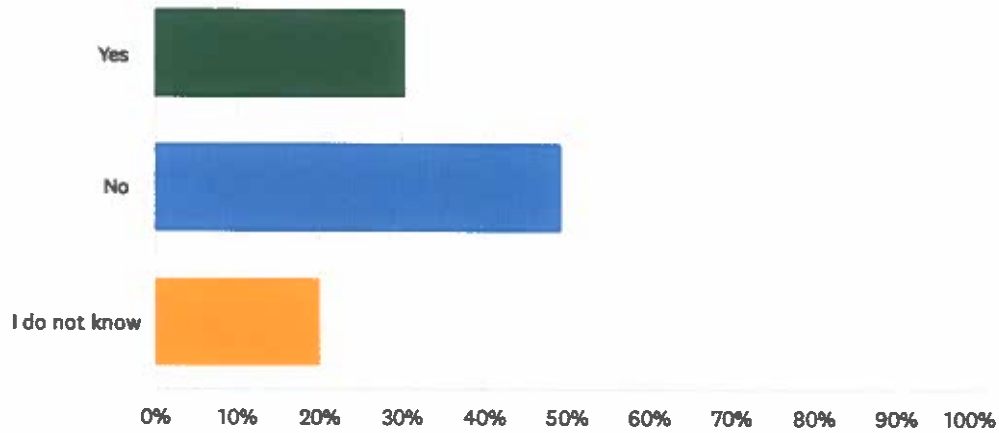

Q39 Do you think that the Hinsdale County Sheriff's department enforced the county regulations and ordinances satisfactorily?

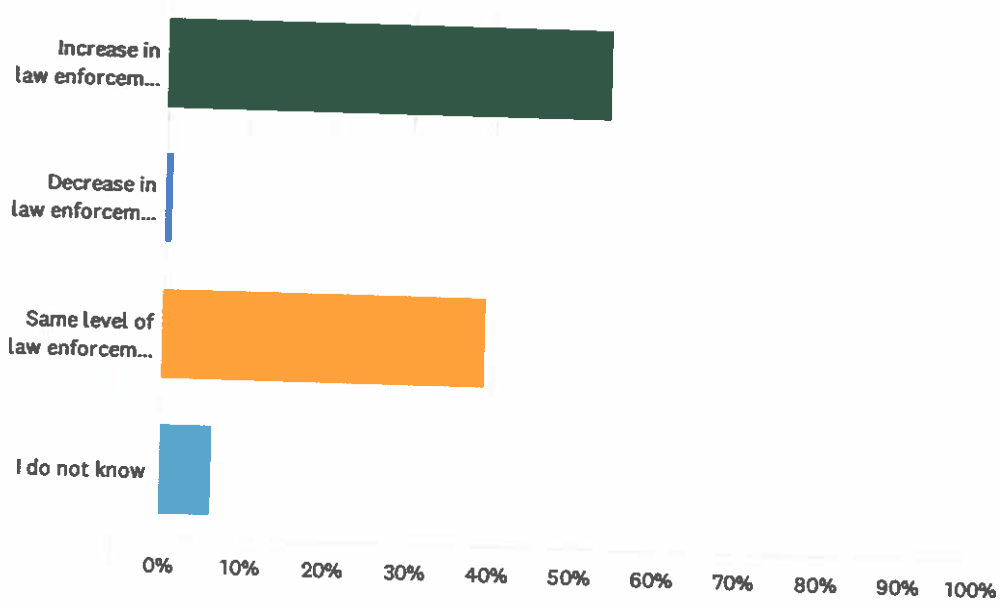

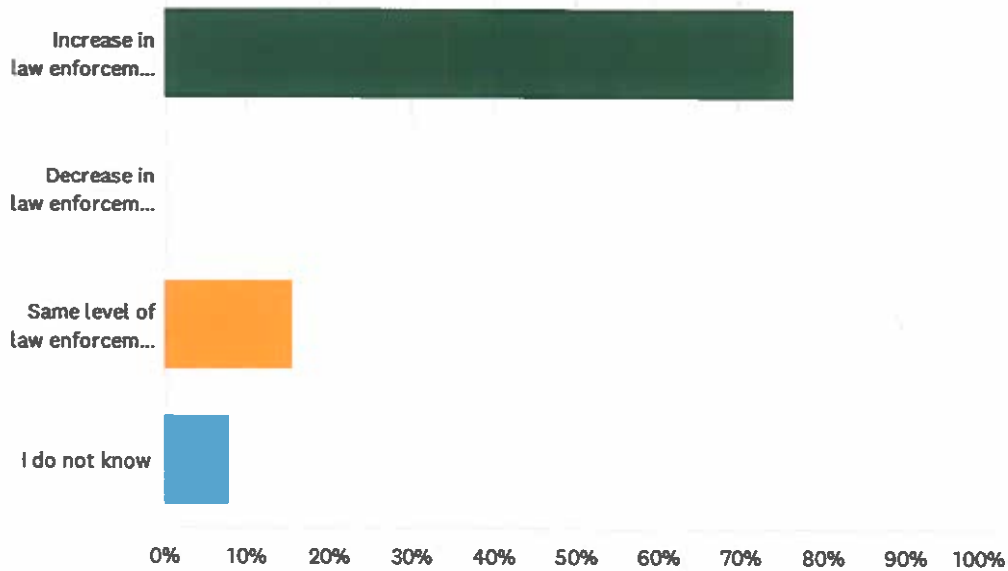

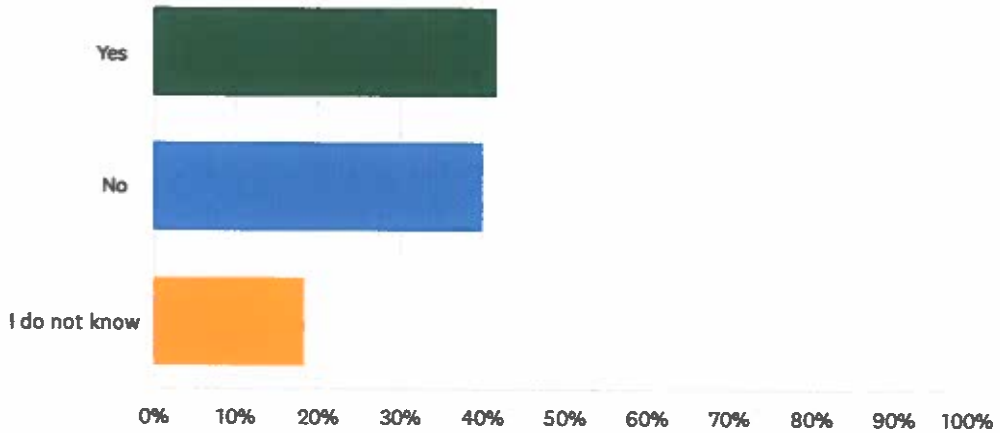

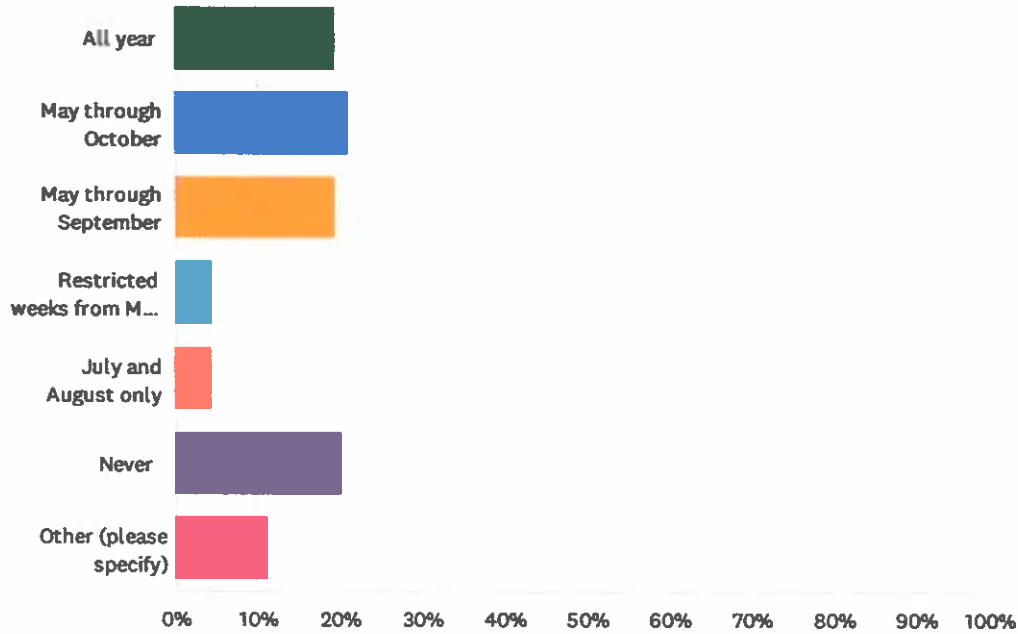

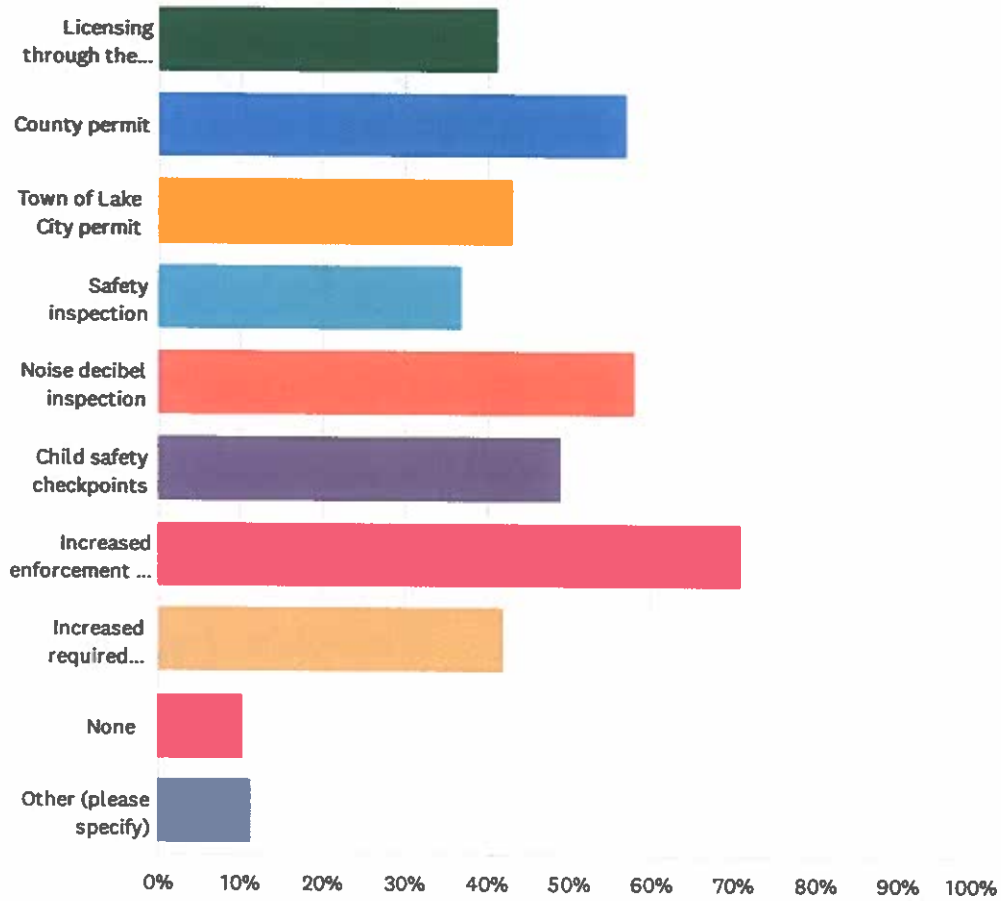

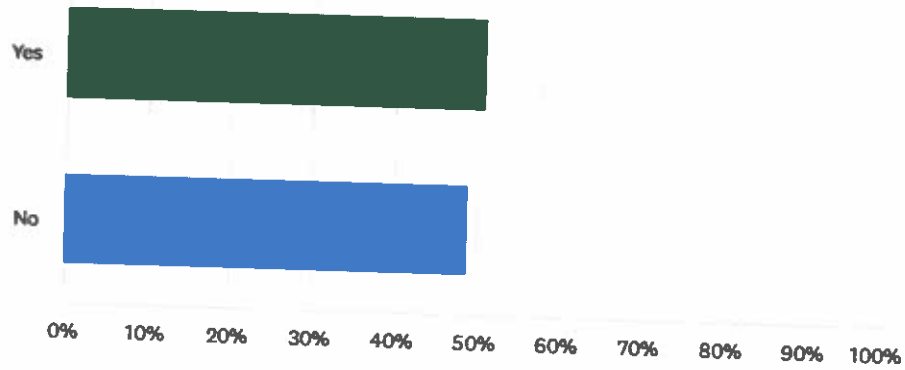

Q46 Do you think that OHVs should be inspected to be permitted on the county roads or highway?

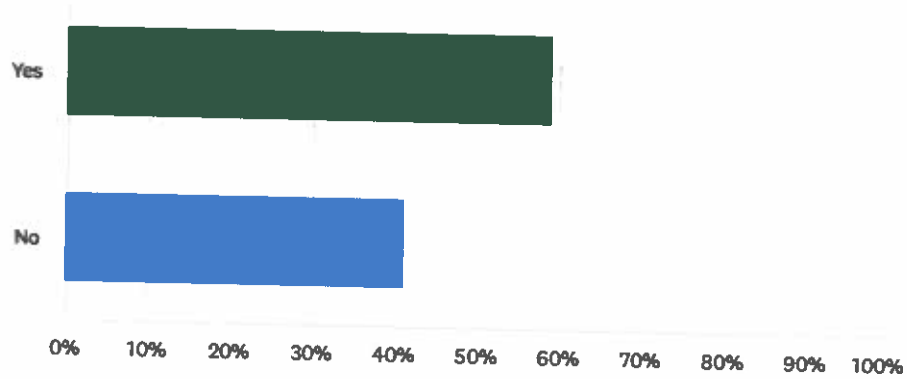

Q47 Do you think that all recreational vehicles should pass a sound decibel test to be permitted on the county roads or the highway?

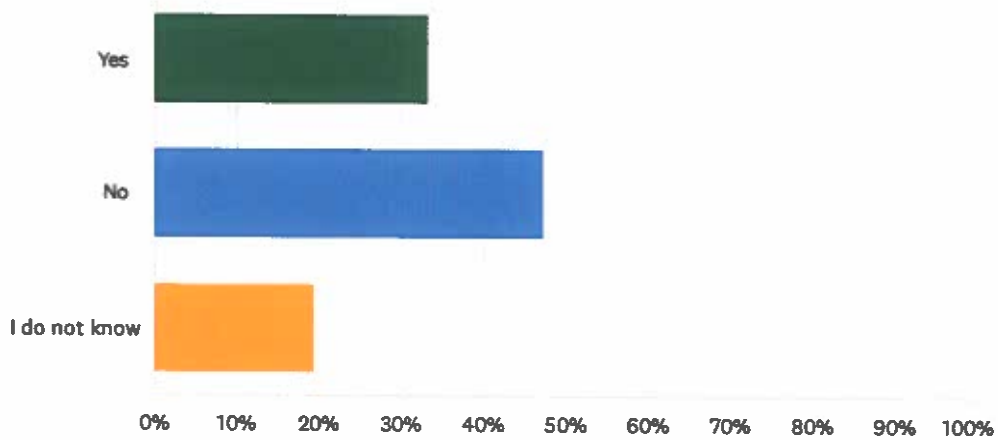

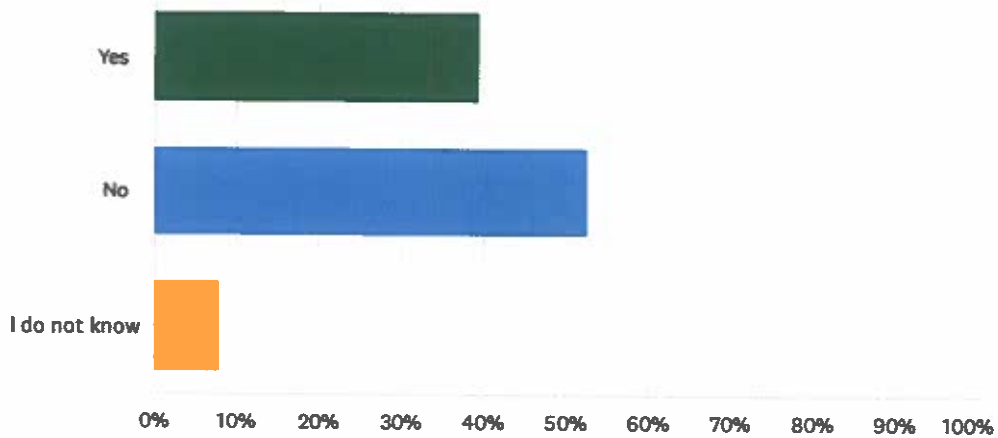

Q49 Would you prefer to see OHVs use the existing staging/loading area outside of town instead of giving OHVs access to Highway 149?

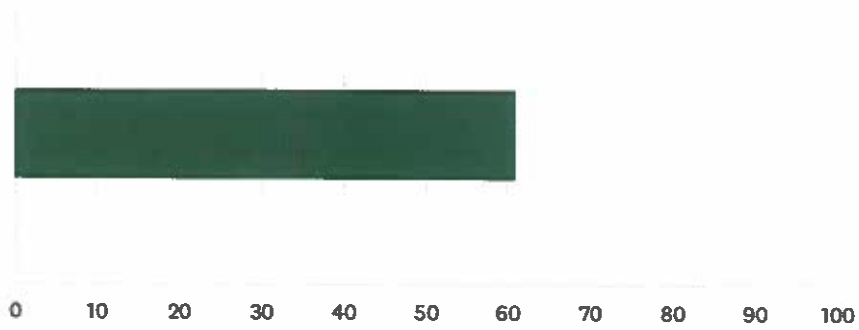

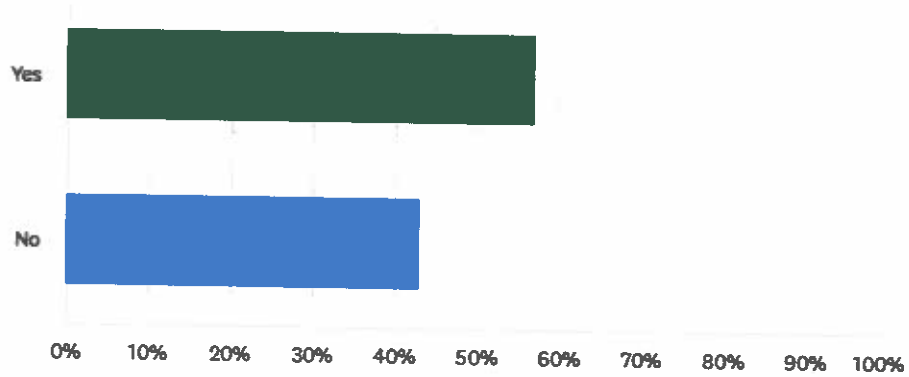

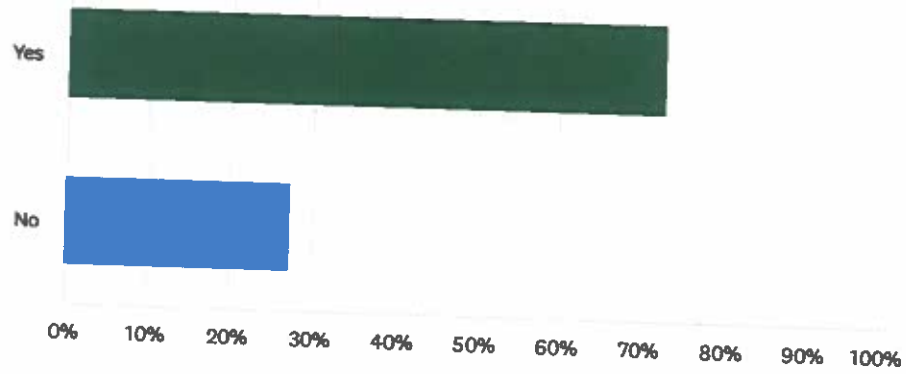

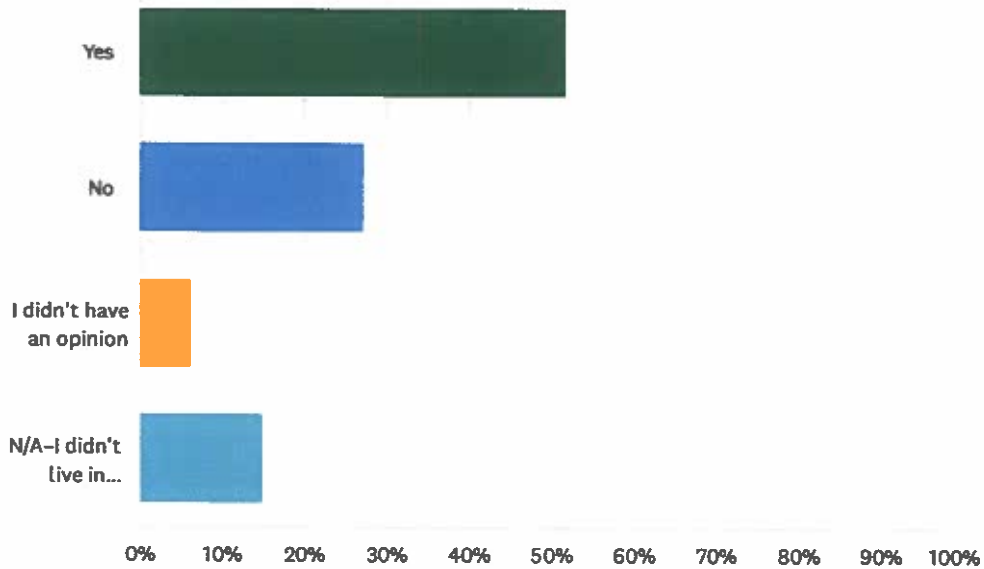

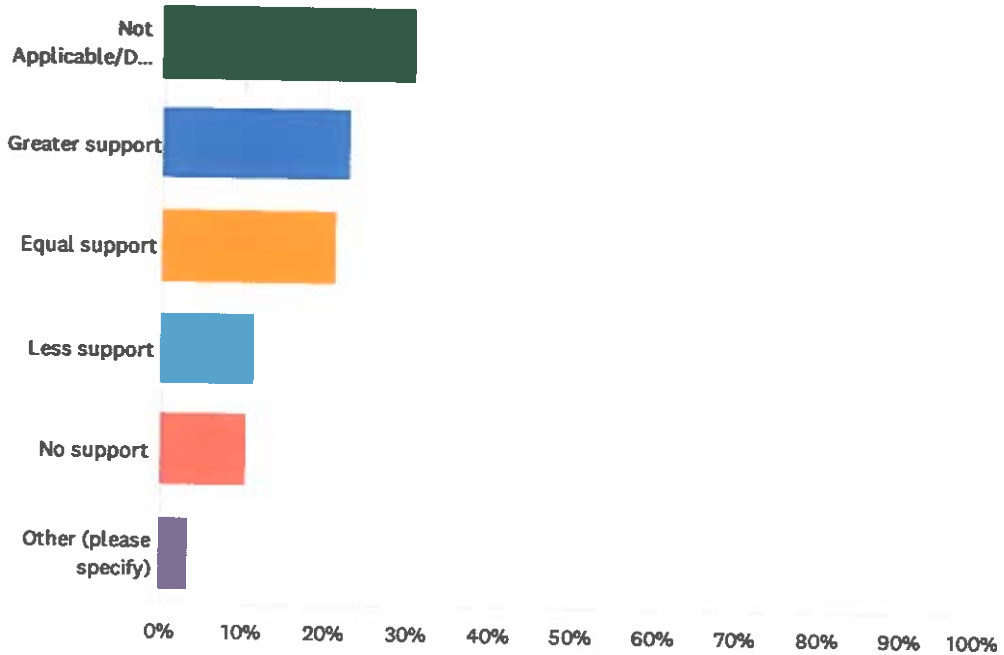

Q54 If you supported the OHV pilot program in 2019, what is your level of support today?

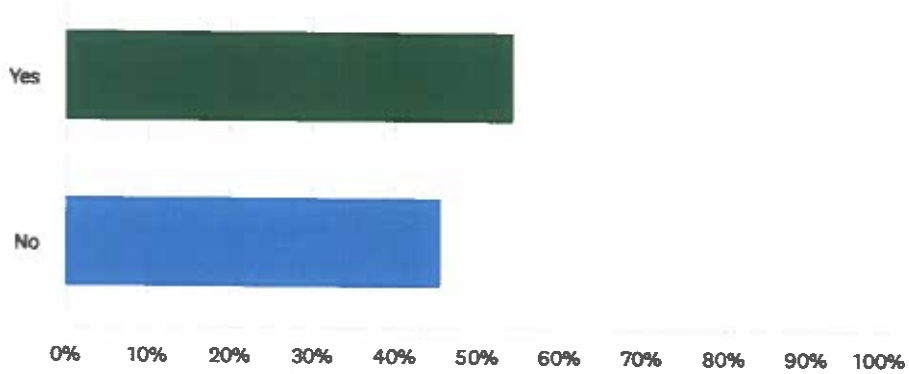

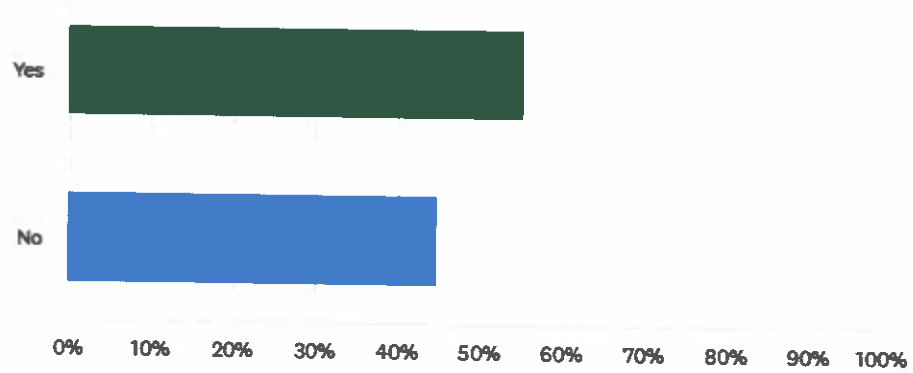

Q56 Do you believe a formal study on the impact that an OHV program has on the environment and wildlife would be beneficial to conduct?

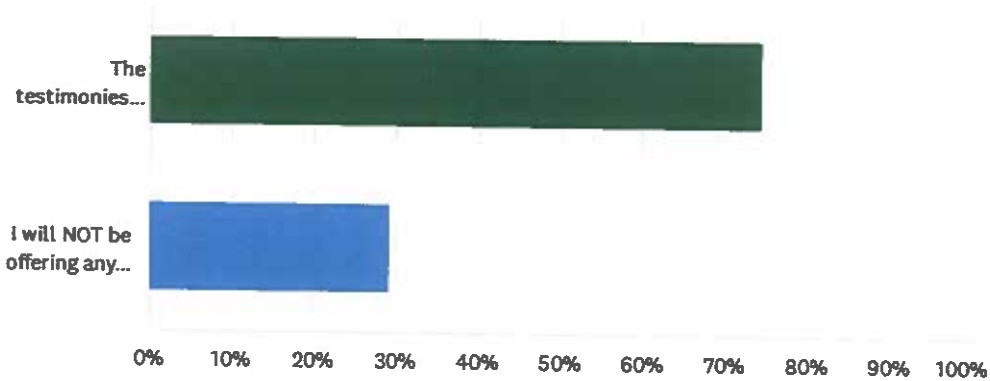
