2025 Accomplishments



- Completed 75% of new County Operations Building funded by Congressionally Directed Spending request, Dpt of Local Affairs (DOLA) Energy Impact grant, public building electrification grant, sale of daycare center, earned income through all-hazards team, and Justice Assistance grant; hired Reynolds Ash + Associates for final design and construction manager; hired Buildings by Design for construction; worked with Alpine Archaeology for monitoring during excavation; put short-term financing in place for cash flow.
- Completed overall policy review process, including repeal of 4 outdated policies and approval of Personal Identifiable Information, Record Retention Schedule, Use of Signature Stamps, Veteran's Transportation, Vehicle Fleet, Public Records, Storage of Privately-Owned Property, Disposal of Abandoned Property, and Website policies; approved updated Organization Chart.
- Declared Upper Piedra flood disaster related to October 11-14, 2025 rain events; implemented Stage 1 fire restrictions when needed.
- Entered intergovernmental agreement (IGA) for Aquatic Nuisance Species inspections; installed gate to limit after-hours boat launches; installed ADA fishing pier (funded by Fishing is Fun! grant); approved 3rd Addendum to Lake San Cristobal Conservation Covenant; completed design and installation for Lookout site and trail (funded by Ben Brownlee Memorial Fund); installed Life Jacket Loaner Station (funded by Sea Tow Foundation); managed boat slips.
- Completed access easement for Ute Ulay access for neighboring property owner; sampled historic transformers.
- Awarded Community Life Saver award to Cory Schulte.
- Appointed Treasurer Lori Hanko in April of 2025; welcomed new deputy treasurer Heather Kuellenberg; cancelled tax sale as all taxes were collected.
- Hired Reynolds Ash + Associates for environmental and archaeological clearances for 11 toilet sites and observatory project (funded by Federal Highway Scenic Byway grant) received Gunnison County Stewardship grant.
- Amended OHV ordinance regulating fires, hours of operation and spark arrestors; completed OHV end of season report; partnered with CDOT to install digital speed signs.
- Purchased Caterpillar 150 Motor Grader.
- Completed repurposing of solar panels at Hill 71 with High Mountain Solutions (funded by DOLA grant) and connected to electric grid.
- Provided forest patrols for Alpine Loop, San Juan National Forest, Rio Grande National Forest, and Gunnison National Forest; provided law enforcement services; raised \$4,500 for Toys For Tots; purchased 2 Ford expeditions for law enforcement; updated IGA with Inmate Housing Services.
- Approved updated Standards & Guidelines with all hazards team; worked with state to resolve billing issues.
- Lodging Tax increase passed by voters to provide funding to early childhood care, Search and Rescue, and Emergency Medical Services. OHV advisory ballot question to submit Colorado Dpt of Transportation (CDOT) permit application passed.



- Completed 2024 audit; held 5 budget workshops and approved 2026 budget; allocated monies received related to national forests and payment in lieu of taxes (PILT); passed a resolution in support of public lands.
- Approved 1 boundary line adjustment; provided planning & zoning commissions recommendations to attorney who will use DOLA's template to draft update; subdivided and completed sale of Mt. Morris to private individual; certified levies and revenues; attended 5 joint meetings with Town; hosted joint meetings with Mineral County and Archuleta County.



- Conducted 20 Search and Rescue missions; secured \$40,675 in SAR grant funds; provided Wilderness First Responder (WFR), Rope Rescue 2, and Flight For Life Lift Ticket trainings for certifications; conducted in-house snowmobile training; held scenario trainings for ice wall rescue, Ute Trail rescue, and Flight For Life rapid deployment team trainings; participated in Colorado Parks and Wildlife photo shoot and video production highlighting the women of SAR – statewide distribution (billboards, online video, etc.); attended SARCON; began Leadership Journey program; provided support to annual Ice Fishing Derby; relocated SAR shed.



- Completed annual Assessor's audit and continue to follow all State guidelines for assessing properties in Hinsdale County performed site reviews for the majority of sold properties; Deputy Assessor maintained Ad Valorem Appraisal License; retained Commercial appraiser for more accurate valuation of commercial properties; kept GIS up to date monthly with title transfers and other property updates; maintain public access to search property records and GIS web map.

- Upgraded Voting System (funded by Secretary of State grant for \$11,266.64 matched with \$4,506.90); completed Clerk's Inventory Audit with Colorado Dpt of Revenue; received 9th ERTB Grant in the amount of \$22,364.25 for Recording System upgrades and maintenance; conducted the Coordinated Election on Nov. 4, 2025.



- Completed facility improvements for Debs Schoolhouse including reducing rodent damage, general clean-up; hosted field trip for Pagosa Open School; approved lease with Visionary and Comnet for Upper Piedra tower.

- Discussed Deer Lakes management with USDA Forest Service.

- Completed the Emergency Management Performance Grant (EMPG) requirements; emergency plans including Emergency Operations, Alert and Warning and Continuity of Operations; created draft Community Animal Response Team (CART) plan with Gunnison County, Colorado State University Extension and the Colorado Department of Agriculture; completed round 2 of the Colorado Emergency Preparedness Assessment; completed the Hinsdale County/Lake City Hazard Mitigation Plan (HMP); completed the draft Hinsdale County Community Wildfire Protection Plan (CWPP), awaiting approval from the Colorado State Forest Service for plan completion.



- Provided emergency medical services for 158 patients; secured \$411,057.60 in funding from EMTS, LCFC, Endowment, WRETAC, SJS50, Friends, and CREATE; added 1 EMT and 2 drivers; trained and cleared 6 EMTs to perform IVs; Chief Paramedic completed critical care endorsement training; trained 2 team members to be Skills Instructors; organized EMT Academy through Arapahoe Community College for 2026; hosted Careflight for a team training; director attended Professional Development Academy; transitioned team to digital paging; approved new Ambulance rates; designed and ordered new ambulance; welcomed new medical director; implemented robust Quality Assurance/Quality Improvement (QA/QI) program; upgraded Med 93 with Incident Command/Medical Branch system; supported new LCAMC Community Paramedic program; set up regular patient follow-up system with Gunnison Valley Health.



- Thanked outgoing marketing consultant Wildpeak Creative and welcomed Mission2Market; created Do Lake City Right campaign; completed Visitor's Guide with Marketing Committee and Chamber of Commerce; updated IGA with alpineloop.info; continued Know Before You Go OHV education campaign.



- Received Underfunded Courthouse Security grant (\$32,000).
- Completed all repairs and final inspection on the four mile section of CR 30 around the lake completing the project; completed road maintenance on 247 total miles of County roads, including snowplowing on 110 of those miles; rebuilt three high country roads, Nellie Creek (GMUG), Round Top (BLM) and Carson Wager (GMUG); continued with graveling operations on CR 30 above Sherman towards Grizzly Gulch; successfully brought all historic county roads back into the magnesium chloride program within budget and on schedule; approved road agreements with Rio Grande and San Juan for mag chloride programs; approved Hold Harmless & Release of Liability agreement for private property owners for winter road access; approved standardized hourly equipment rates with Town.



- Approved 2 national opioid settlement agreements; proclaimed May as Mental Health Awareness month; proclaimed September as Suicide Prevention month.
- Updated the Veterans Memorial Wall; hosted weekly Veterans Meet and Greet at the museum; created outreach program through the newspaper and social media; implemented Wreaths Across America Program; successfully assisted all Veterans in their individual VA needs; hosted Memorial Day and Veteran's Day services, led flag display for Fourth of July.



- Updated rates of disposal for natural timber and slash; received National Disaster Mitigation grant (\$60,000) for future chipping of debris; updated signs at Transfer Station; approved Smoke Management plan.
- Conducted Board of Equalization hearings.
- Approved 2 retail liquor licenses; approved 4 special event liquor permits; approved 9 special event permits.
- Amended floodplain drainage permit ordinance.



- Discussed exterior lighting initiatives; received updates on Lake San Cristobal fuels project, 30 Mile Resort, and 7th Judicial District Attorney's office.
- Passed resolution to expedite review policies for Affordable Housing projects; requested and received approval to reclassify Hinsdale County from rural to rural resort.
- Attended 20 hours of American Board of Medicolegal Death Investigator approved Continuing Education through the Colorado Coroner's Association (Coroner & 2 deputies); obtained coroner office space; maintained team of deputy coroners; monthly meetings; established regional coroner relationships; attended Mass Fatalities Planning and Response for Rural Communities; assembled deployment bags for aquatic death, skeletal remains, mass casualty and airborne backcountry body recovery; conducted aquatic death field exercise; attended bi-monthly Tri-County Health Network Suicide Prevention, Awareness, and Recovery Coalition meetings; Member of the Colorado Coroners Association Coroner Assist Team; Coroner began coursework for the Grief Educator Certification program to better serve the bereaved in our community; 2 Deputy Coroner's completed the certification process through the Colorado Coroner's Association as certified death investigation; joined Search and Rescue as a member of the Flight for Life helicopter based rapid deployment team to obtain certification and readiness for backcountry body recovery missions.

- Seek funding for new water delivery system at Wupperman Campground.

- Stay involved with assessment work on Slumgullion Earthflow with Lake Fork Valley Conservancy.

Sheriff's Office

- Provide professional law enforcement services through responsive, caring, and dedicated service.
- Continue to provide appropriate training opportunities that will enhance the capabilities of all office personnel and allow us to better serve our community.



- Work with San Juan County on the "Dave" Memorial on the top of Cinnamon Pass.
- Purchase and stockpile gravel in the South End for much needed regraveling on County Road sections.
- Work on finding a gravel source within the county for county roads.

- Continue to work with Gunnison County on extending cell coverage north on Hwy 149 to Gunnison, specifically constructing a cell tower on Rose Ridge.
- Support efforts to utilize Starlink options where needed to improve communication.
